

## Cooperation agreement

Karabuk, Turkey

Karabuk University in Turkey (KBU), hereinafter referred to as "Institute", represented by the Rector Prof. Refik Polat, acting under the Charter, on the one hand, and the Navoi State Mining Institute, hereinafter referred to as "the Institute", represented by the Rector Prof. Sanakulova Kuvandyk Sanakulovich, acting under the Charter, on the other hand, collectively referred to as the "Parties", Recognizing the need to deepen the comprehensive integration relations between the Republic of Turkey and Uzbekistan, in order to further the development of international cooperation and the strengthening Foreign relations in the field of education between the higher educational institutions of the Republic of Turkey and the Republic of Uzbekistan, have concluded this Agreement on the following:

### 1. Agreement subject

1.1. The subject of the Agreement is the establishment of mutually beneficial cooperation between the Parties in the field of educational activities, including:

- development of cooperation in the field of education and science;
- assistance in the effective functioning of higher education systems and post-graduate professional education, training highly qualified specialists with higher education and highly qualified scientific personnel, continuous professional development of employees;
- Integration of professional education and science.

1.2. Cooperation in the framework of international projects using the human resources of the Parties.

### 2. Terms of Agreement

2.1. The implementation of this Agreement will be implemented jointly by both Parties in the following forms:

2.1.1. Mutual cooperation and exchange of experience in the improvement of the educational process, in the use of modern methods and systems of instruction, in the application of innovative technologies in the educational sphere.

2.1.2. Exchange on a reciprocal basis of educational and methodological materials, curricula and programs on training specialists.

2.1.3. Organization of familiarization, production and other types of practices through the provision of services on the terms and conditions accepted for students from the host Party.

2.1.4. Organization of the exchange of the most gifted senior students for continuing education and / or performance of the thesis work, projects on the conditions established for students from the host Party.

2.1.5. Exchange of information on the subjects, organization and results of scientific research.

2.1.6. Joint implementation of research and development work.



2.1.7. Joint work in international research and educational projects.

2.1.8. Invitation of highly qualified specialists for lecturing, holding seminars and scientific consultations.

2.1.9. Organization of short-term scientific and educational internship and advanced training for teachers, staff, doctoral PhD and undergraduates, in accordance with the rules and regulations of the host Party.

2.1.10. Exchange of information on planned scientific conferences, scientific seminars and other events aimed at the implementation of this Agreement, creating conditions for the participation of representatives of the Parties in them.

2.1.11. Mutual cooperation in the publishing activities of the Parties.

2.1.12. Cooperation in the development of educational, scientific and methodological materials, programs for the organization of a system of three-level training (bachelors, masters, PhD doctors), in peer review of master's and doctoral dissertations.

2.2. As the regulatory and legal framework regulating cooperation between the Republic of Turkey and the Republic of Uzbekistan in the field of education and science improves, other mutually agreed forms of cooperation are possible to ensure the implementation of this Agreement.

The content of other forms of cooperation, their organizational matters, will be agreed upon by the Parties additionally.

2.3. Financing of the activities implemented within the framework of this Agreement should be carried out by both Parties and determined by their financial capabilities.

### **3. Special conditions**

3.1. All other relations of the Parties of applied nature for specific activities are carried out by concluding separate contracts and contracts.

3.2. The present Agreement does not exclude the possibility of making changes and additions to it.

All changes and additions to this Agreement are made out by additional agreements that are valid if they are made in writing and signed by authorized persons of the Parties.

3.3. Participation in this Agreement does not limit the right of Parties to participate in any other forms of international cooperation in the field of education and science.

### **4. Validity of the contract**

4.1. This Agreement comes into force from the date of its signing by the Parties and is valid for 5 (five) years.

If one of the Parties does not declare its termination or amendment one month before the expiration of this Agreement, this Agreement shall be prolonged for the same period and on the same terms.

4.2. This Agreement may be terminated ahead of time on the initiative of one of the Parties, which the other Party must be notified in writing at least 3 (three) months before the expected date of termination of the Agreement.



## 5. Final provisions

5.1. This Agreement is made in English in two copies having equal legal force, one for each Party.

5.2. The conditions not stipulated by this Agreement are regulated in accordance with the current legislation of the Republic of Turkey and the legislation of the Republic of Uzbekistan.


