As a general declaration of intent, both parties agree to act as follows:

1. This MOU shall encourage the following activities and related fields.
 - (1) Exchange of professors and researchers
 - (2) Exchange of undergraduate and graduate students
 - (3) Other activities that may be effective for both parties regarding international exchanges
 - (4) Preparing common projects on distance learning and EU programmes.
2. The aforementioned activities shall be realized by means of consultation, including the exchange of relevant information that is deemed appropriate between the two parties.
3. This MOU shall become effective immediately upon being signed by a representative of each party, and remain effective for a period of five (5) years. It shall be automatically renewed for subsequent periods of five (5) years unless either party gives to the other party a written notice of nonrenewal at least six (6) months prior to the expiration of the then current MOU.
4. This MOU may be amended by mutual agreement in writing.
5. This MOU, as well as any subsequent agreements modifying or explaining its details, shall be written in English and signed by representatives of each party. Copies are to be kept by both parties.
6. This MOU is subject to, and shall be interpreted in accordance with the laws of Poland if a dispute arises in Poland, or the laws of Turkey if a dispute arises in Turkey
7. Specific mechanisms for the implementation of cooperative and collaborative activities shall be conferred and specifically described in a separate agreement.
