For student Mobility: Students from foreign partner institutions willing to study at University North should contact the International Relations Office. Students have to post the application form, accompanied by a transcript of records (filled in by their home university) and Learning Agreement to IRO. Learning Agreement may be modified after arrival and discussion with faculty coordinator. The final version must be delivered to the IRO not later than 5 weeks after arrival.

The School's buildings are adapted for people with minor handicaps.

For staff mobility, the Teaching programme or Working programme form duly filled in and signed by home university should be sent to IRO.


