When the Inter-Institutional Agreement Manager is released, it will be accompanied by a more detailed data standard, to which all equivalent systems will then need to adhere.

The institutions agree on exchanging their mobility related data in line with the technical standards of the European Student Card Initiative.

Termination of the agreement

The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]
