



## **MEMORANDUM OF COOPERATION**

**between K.Zhubanov Aktobe Regional University  
and Karabük University**

K.Zhubanov Aktobe Regional University (the Republic of Kazakhstan, Aktobe, A.Moldagulova Prospekt 34), represented by Rector Professor, Dr. **Laura Karabassova**, hereinafter referred to as K.Zhubanov ARU, and Karabük University (Kastamonu Yolu Demir Çelik Kampüsü, 78050 Kılavuzlar/Karabük Merkez/Karabük, Turkey), represented by Rector Professor, Dr. **Refik Polat**, hereinafter referred to as Karabük University, wishing to enhance relations between the two universities and to develop academic and cultural exchange in the area of education and other activities, have agreed to the following:

### **Article 1**

The purpose of this Memorandum is to establish the cooperation in the fields of science, education, training, research and administrative community services between the K.Zhubanov Aktobe Regional University (Republic of Kazakhstan) and Karabük University (Turkey) in areas of mutual interest

### **Article 2**

The Parties agree that their cooperation may include but not be limited to the following areas:

- 1) Exchange of researchers
- 2) Exchange of faculty for scientific research holding and lecturing
- 3) Exchange of students
- 4) Transfer of students
- 5) Exchange of staff members for sharing of experience
- 6) Summer School
- 7) Foreign scientific internships for master and doctoral students
- 8) Exchange of scholarly and pedagogical materials
- 9) Joint research/programs/projects
- 10) Technical assistance and/or training
- 11) Publishing research papers in peer-reviewed journals
- 12) Development of double-diploma/joint educational programmes
- 13) Other cooperative efforts as may be specified later

### **Article 3**

The establishment of the cooperation of the Parties, the programmes and activities, their objectives, costs and achievements should be specified and approved in separated agreements that should include the general description of the activities, the staff involved, the duration of the specific programme and the financial arrangements and the agreement on intellectual property rights for its implementation. The Parties agree that no obligation (especially, but not limited to

the obligation to fund any activity, project or program under the scope of this MOU) may rise from this MOU, unless otherwise specified in a separate, written agreement of the Parties.

#### Article 4

The Parties agree that all specific arrangements and plans for activities are to be negotiated and depend on the availability of funds. The Parties will seek funding for the activities defined in this MOU from various sources.

#### Article 5

The present MOU enters into force on the day when both Parties have signed it, and will remain in force for five (5) years. Both Parties may terminate this MOU with a six (6) month's prior written notice. This MOU may be amended or modified at any time by mutual consent in writing by both Parties.

#### Article 6

K.Zhubanov ARU and Karabük University shall abide by the policy of equal opportunity in the administration of this MOU and neither institution shall impose criteria for the exchange of scholars or students, which would violate the principles of non-discrimination. This Memorandum is concluded in two examples in English and Russian languages both possessing equal power. The Parties have signed the present MOU as being consistent with their will and consent.
